1. State Electric Company Ltd (STELCO) invites sealed Bids from interested and eligible Bidders for the above mentioned tender. **This Invitation for Bid is open for both local and international Bidders.**
2. A complete set of Bidding Documents may be purchased by interested and eligible Bidders from STELCO's head office in Male', from **17th October 2017 to 30th October 2017** between **09:00 hrs to 15:00 hrs** on all working days, upon payment of a non-refundable fee of US\$200.00 (United States Dollars Two Hundred only) or MVR 3,084.00 (Three Thousand and Eighty Four Maldivian Rufiyaa only) in cash or telegraphic transfer directly to our head office. Overseas Bidders shall pay additional US\$50.00 (United States Dollars Fifty only) if they require the documents to be delivered to their mailing address. Documents shall be issued from **22nd October 2017 to 30th October 2017** between **09:00 hrs to 15:00 hrs** on all working days.
 - Only Bidders **who purchase** the Bidding document can participate and thus the document is **not transferable**.
3. The Bid Validity shall be minimum Sixty (60) days from the date of Bid opening. All Bids shall be accompanied with a Bid Security of MVR 20,000.00 (Twenty Thousand Maldivian Rufiyaa only) which is valid for Thirty (30) days beyond the validity of the bid. The Performance Security shall be 15% of the Bid Price. Bid Security and Performance Security shall be either a bank guarantee letter (as per the format in the bid document), bank certified cheque or bank draft.
4. A pre-bid meeting shall be held on **Tuesday, 31st October 2017** at **11:00hrs** local time at **STELCO Head Office, 2nd Floor meeting room**.
5. All Bids shall reach STELCO head office on or before **Thursday, 09th November 2017**, at **11:00 hrs**.
