

Invitation for Bids
Supply of 02 Nos of Medium Speed Gen Sets and accessories

1. State Electric Company Ltd (STELCO) invites sealed Bids from interested and eligible Bidders for the above mentioned tender. **This Invitation for Bid is open for both local and International Bidders.**
2. A complete set of Bidding Documents may be purchased by interested and eligible Bidders from STELCO's head office in Male', from **25th December 2017 to 08th January 2018 between 09:00 hrs to 15:00 hrs** on all working days, upon payment of a non-refundable fee of US\$200.00 (United States Dollars Two Hundred only) or equivalent in Maldivian Rufiyaa in cash or telegraphic transfer directly to our head office. Overseas Bidders shall pay additional US\$50.00 (United States Dollars Fifty only) if they require the documents to be delivered to their mailing address. Documents shall be issued from **28th December 2017 to 08th January 2018 between 09:00 hrs to 15:00 hrs** on all working days.
 - Only Bidders **who purchase** the Bidding document can participate and thus the document is **not transferable**.
3. The Bid Validity shall be minimum Fifty (50) days from the date of Bid opening. All Bids shall be accompanied with a Bid Security of MVR 20,000.00 (Maldivian Rufiyaa Twenty Thousand only) or equivalent in United States Dollar which is valid for Twenty (20) days beyond the validity of the bid. The Performance Security shall be 15% of the Bid Price. Bid Security and Performance Security shall be a bank guarantee letter (as per the format in the bid document), bank draft or an insurance policy.
4. A pre-bid meeting shall be held on **(Tuesday), 09th January 2018 at 11:30hrs** local time at **STELCO Head Office, 2nd Floor meeting room**.
5. All Bids shall reach STELCO head office on or before **Wednesday, 17th January 2018, at 11:30 hrs** local time.
