

**Invitation for Bids**  
**Supply of Cables under Supplier's Credit**

1. State Electric Company Ltd (STELCO) invites sealed Bids from interested and eligible Bidders for the above mentioned tender. **This Invitation for Bid is open for both local and International Bidders.**
2. A complete set of Bidding Documents may be purchased by interested and eligible Bidders from STELCO's head office in Male', from **03<sup>rd</sup> December 2017 to 14<sup>th</sup> December 2017 between 09:00 hrs to 15:00 hrs** on all working days, upon payment of a non-refundable fee of US\$300.00 (United States Dollars Three Hundred only) or equivalent in Maldivian Rufiyaa in cash or telegraphic transfer directly to our head office. Overseas Bidders shall pay additional US\$50.00 (United States Dollars Fifty only) if they require the documents to be delivered to their mailing address. Documents shall be issued from **06<sup>th</sup> December 2017 to 14<sup>th</sup> December 2017 between 09:00 hrs to 15:00 hrs** on all working days.
  - Only Bidders **who purchase** the Bidding document can participate and thus the document is **not transferable.**
3. The Bid Validity shall be minimum Fifty (50) days from the date of Bid opening. All Bids shall be accompanied with a Bid Security of MVR 500,000.00 (Maldivian Rufiyaa Five Hundred Thousand only) or equivalent in United States Dollar which is valid for Twenty (20) days beyond the validity of the bid.
4. A pre-bid meeting shall be held on **Sunday, 17<sup>th</sup> December 2017 at 11:00hrs** local time at **STELCO Head Office, 2<sup>nd</sup> Floor meeting room.**
5. All Bids shall reach STELCO head office on or before **Sunday, 31<sup>st</sup> December 2017, at 11:00 hrs.**
